

Mayflower College Admissions Policy

Mayflower College accepts applications via post, email, online or in person. All students are requested to complete an enrolment form (to include name, date of birth, address, visa status (if required), including passport details, any medical illnesses/allergies, next of kin and preferences for homestay accommodation, if required.

Procedures

- Bookings can be made by post, email, fax, telephone, website (online) or in person.
- Bookings are accepted through students contacting the school directly (as well as from agents).
- A deposit of £150 is required to confirm enrolment (some visa nationals may be required to pay fees in full prior to issuing a confirmation letter).
- Full payment of fees is requested 4 weeks prior to the start of the course.
- All courses are subject to availability where possible alternative dates or a refund will be offered.
 Dates of public holidays are published at the bottom of the enrolment form and full-day excursions are offered instead of lessons on these days.
- Enrolment forms should be completed in full, taking care to read the terms and conditions of enrolment.

Entry Requirements

Mayflower College requires students to have studied English previously (we are not able to cater for absolute beginners). We may refuse to accept a student based on academic needs, if we feel we cannot meet those needs, for example the student is an absolute beginner or the level is higher than the current level of classes running in the school. If students are sponsored by their Embassy or employer, we ask for proof of sponsorship prior to acceptance.

General English courses

Minimum age for **Adult General English** courses is 16 years. All students are requested to take the Mayflower College entrance test prior to arrival at https://poll-maker.com/Q22IMY

IELTS Preparation Courses

Minimum age for IELTS Preparation courses is 16 years.

Junior Courses

Short-term study visa

For children/ adults who want to study a short course in the UK (and do not intend to work in the UK) A Short term study visa allows students to study for up to 6 or 11 months. You can read more about this visa here https://www.gov.uk/study-visit-visa

Enrolment Policy

In order to enrol a student requiring a **Short term study visa**, we the following:

- Copy of passport (please scan and email a copy)
- Completed enrolment form http://www.maycoll.co.uk/enrolmentform.html
- A deposit payment of GBP150 (balance of fees payable 4 weeks prior to arrival) details on how to pay are given at http://www.maycoll.co.uk/english/payment.htm
- Some visa nationals may be required to make payment of course and accommodation fees in full.

Fees will be refunded if the applicant's visa application is unsuccessful (less the non- refundable deposit of £150). Please send a copy of your UKVI refusal letter to ensure prompt return of any payments.

Admissions Policy for Students with Disabilities or Special Educational Needs

The Equality Act 2010 defines 'protected characteristics' (i.e. grounds upon which discrimination is unlawful). One of these 'protected characteristics' is disability. Under the Equality Act 2010 a person is classified as disabled if they have a physical or mental impairment which has a substantial and long-term effect on their ability to carry out normal day-to-day activities. Day-to-day activities include using a telephone, reading a book or using public transport.

Mayflower College is committed to providing equality of opportunity to all students. We recognise that we have a duty to make reasonable adjustments to ensure disabled students are not discriminated against. However, Mayflower College has limited facilities (such as wheelchair access) for disabled students.

Policy statement:-

- 1. Mayflower College requires all students to declare any disabilities and special educational needs at enrolment.
- 2. Declaration will allow the school to make provision for the student in what ever way is deemed reasonably possible and practicable or to propose alternative arrangements if adjustments cannot reasonably be made.
- 3. If a disability or special need is not declared at the time of enrolment but is identified after arrival at school, this could result in the school not being able to provide the contracted services for the student. In this case the Mayflower College will assist students to transfer to another school or for the student to return home.

Cases where applications may be refused

The Mayflower College requires students to have studied English previously (we are not able to cater for absolute beginners). We may refuse to accept students in the following cases:

- (1) If we cannot meet their academic needs for example the student is an absolute beginner or the level is higher than the current level of classes running in the school.
- (2) if we feel that we cannot meet the needs of the student based on their medical grounds;
- (3) if there is a suspicion or risk that the student will not comply with the requirements of their visa status (or if there is a suspicion that documents presented to support a visa application are not bonafide).
